## SECTION 4. First-Aid Measures

## SECTION 5. Fire-Fighting Measures

**UNUSUAL FIRE AND EXPLOSION HAZARDS:** Vapors/dust may form explosive mixture with air. Vapors can travel to a source of ignition and flash back. Empty containers retain product residue (liquid and/or vapor) and can be dangerous. DO NOT pressurize,
