Precautionary Statements - Response

4. FIRST AID MEASURES**First aid measures****General advice**

If symptoms persist, call a physician.

Eye contact

Flush immediately with plenty of water for 15 minutes. Lift upper and lower eyelids for complete rinsing. If irritation persists after rinsing, get medical attention.

Skin Contact

Flush with water for 15 minutes. If irritation persists after rinsing, get medical attention. Remove contaminated clothing and wash before reuse.

Inhalation

Remove victim from immediate source of exposure to fresh air. If breathing is difficult, administer oxygen if available. If victim is not breathing, administer CPR. If individual experiences nausea, headache, or dizziness, get immediate medical attention.

Ingestion

Rinse mouth with water. Give water to dilute. Do not induce vomiting. Get immediate medical attention. Never give anything by mouth to a semi-comatose, comatose, convulsing or unconscious person.

5. FIRE-FIGHTING MEASURES**Suitable extinguishing media**

Water spray (fog). Dry chemical. Carbon dioxide (CO₂). Alcohol resistant foam.

Unsuitable extinguishing media Avoid using a direct stream of water.

Specific hazards arising from the chemical

Flammable. Vapors can travel to a source of ignition and flash back. Empty containers retain product residue (liquid and/or vapor) and can be dangerous. DO NOT pressurize, cut, weld, braze, solder, drill, grind, or expose such containers to heat, flame, sparks, static electricity, or other sources of ignition. Also, do not reuse container without commercial cleaning or reconditioning.

Hazardous combustion products Aldehydes. Carbon oxides. Ketones. Organic acids. Toxic gases/fumes are given off during burning or thermal decomposition. During combustion carbon monoxide may be formed. During combustion carbon dioxide may be formed.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

- Personal precautions** Evacuate nonessential personnel. Avoid contact with eyes, skin and clothing. Ventilate area. Wear appropriate personal protection equipment. Remove all sources of ignition.
- Environmental precautions** See Section 12 for additional ecological information.
- Methods for containment** Stop leak if safe to do so. Completely contain spilled material with dikes or sand bags, etc. Absorb spill with inert material (e.g. dry sand or earth), then place in a chemical waste container. Remove free liquid. Contain spill and keep from entering waterways or sewers.
- Methods for cleaning up** Recover as much material as possible into containers for disposal or reuse. Flush spill area with water.

7. HANDLING AND STORAGE

Precautions for safe handling

- Advice on safe handling** Do not get in eyes, on skin, or clothing. Do not breathe vapors or mists. Do not ingest. Wash thoroughly after handling. Wear protective clothing/equipment. Use with adequate ventilation.
- Conditions for safe storage, including any incompatibilities**

- Storage Conditions** Keep containers tightly closed and properly labeled. Keep away from heat/sources of ignition. Containers that have been emptied will retain product residue and should be handled as if they were full. Store in a cool, dry, well-ventilated place away from incompatible materials. Wash hands before eating, drinking, using tobacco, applying make-up or using the toilet. Do not store, use, and/or consume foods, beverages, tobacco in areas where this product is stored.
