4. FIRST AID MEASURES**First aid measures**

General advice	If symptoms persist, call a physician.
Eye contact	Flush immediately with plenty of water for 15 minutes. Lift upper and lower eyelids for complete rinsing. If irritation persists after rinsing, get medical attention.
Skin Contact	Flush with water for 15 minutes. If irritation persists after rinsing, get medical attention. Remove contaminated clothing and wash before reuse.
