4. FIRST AID MEASURES

First aid measures

5. FIRE-FIGHTING MEASURES

If the stock solution container breaks, the solution should be handled with care as it is corrosive. The product causes irritation of eyes, skin and mucous membranes. Thermal decomposition can lead to release of irritating and toxic gases and vapors.
