4. FIRST AID MEASURES

First aid measures**General advice**

Immediate medical attention is required.

Eye contact

Flush immediately with water for 15 minutes. Lift upper and lower eyelids for complete rinsing. Get immediate medical attention.

Skin Contact

Flush with water for 15 minutes. Get medical attention. Remove contaminated clothing and wash before reuse.

Inhalation

Remove victim to fresh air. If breathing difficulty occurs or persists, get medical attention.

Ingestion

Rinse mouth with water. Give water to dilute. Do not induce vomiting. Get immediate medical attention. Never give anything by mouth to a semi-comatose, comatose, convulsing or unconscious person.

Self-protection of the first aider

Most important symptoms and effects, both acute and delayed

Symptoms Corrosive. Causes irritation (possibly severe), burns to the eyes. May cause permanent eye damage. Causes irritation (possibly severe), burns to the skin. Causes irritation (possibly severe), burns, pulmonary edema to the respiratory tract. Causes irritation (possibly severe), burns, nausea, vomiting to the gastrointestinal tract. Indication of any immediate medical attention and special treatment needed

Note to physicians Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure.
