SECTION 4: First aid measures

Description of first aid measures

After inhalation:

Move exposed individual to fresh air. Loosen clothing as necessary and position individual in a comfortable position. Seek medical advice if discomfort or irritation persists. If breathing difficult, give oxygen.

Protective equipment:

Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air. Collect solids in powder form using vacuum with HEPA filter.

Precautions for safe handling:
